Campground Guidelines:

1. Campers should be placed 10 feet from neighbors.
2. Campers must be 15 feet from dump site & 10 feet from buildings.
3. No burning on the ground. Fires must be in an above ground, metal fireplace.
4. Dogs must be kept on a leash. Owners must respect fellow campers and the Green County Fair Association by controlling barking and by picking up after your pet.
5. Prices are based on one camping vehicle/tent per space. Additional tenants per space will result in additional fees.
6. Fees must be paid to attendant or at the Fair Office. There is a \$35 NSF charge for any and all returned checks.
7. The Green County Fairgrounds reserve the right to deny or remove any campers.

Notice to Guest:

This property is privately owned. The camper accepts camping privileges with the understanding that he/she does hereby release the Green County Fair Association, its officers and employees of all liability for loss or damage to property and injury to his person arising out of his use of its camping facilities, and agrees to indemnify the Green County Fair Association, its officers and employees, against claims resulting from loss or damage to property or injury to person of any member of the family or guest of the registered camper arising out of the use of its camping facilities. Camper acknowledges that camping privileges are for the period of their check-in date until 12:00 pm the day following their paid thru date and have no rights or claims beyond those dates. Camper acknowledges that should their check be returned as non-sufficient funds, camper will pay owed fees plus a \$35 NSF charge. UPON FAILURE TO SIGN THIS FORM, GUEST(S) ARE ASSUMING FULL LIABILITY OF PERSONAL PROPERTY AS WELL AS DAMAGES TO THE FAIRGROUNDS.
