EXHIBITION HALL (166' N/S x 67' E/W)

- \$450 for THREE days + current rate of trash removal
- \$150 for use of Cooler
- Additional Charge* \$150/day

PAVILION (80' E/W x 57' N/S)

- \$450 for THREE days + current rate of trash removal
- \$300 for EACH wing of Pavilion (East Wing; West Wing)

BEER GARDEN

- \$50.00/day + current rate of trash removal
- PLUS \$250 Security Deposit Required

BUILDING 13- Youth in Action

- \$450 for THREE days + current rate of trash removal
- Additional Charge* \$150/day

REMAINING BUILDINGS (Including Annex)

- \$450 for THREE days + current rate of trash removal
- Additional Charge* \$150/day

BATHROOMS

- \$100 for THREE days

OUTSIDE SPACE- depends on the area rented

AMPHITHEATER (capacity 1750)

- \$1,750 for THREE days + current rate of trash removal

ACTIVITIES RESTRICTING ADDITIONAL USE OF GROUNDS*

- \$1,750 for THREE days + current rate of trash removal

TRASH REMOVAL RATES

- Current Rate of Disposal: \$60/cu yard

CAMPING

- RV/Campers \$30/night
- Tent \$20/night
- *If camping by month the charge is \$500*

SEWER DUMP

- Campers \$5
- Non-campers \$30

WINTER STORAGE

- Cars \$175 + Tax
- Motorcycles/UTV \$80 + Tax
- Boats \$13/ft + Tax
- Campers, RVs \$13/ft + Tax (if drivable, Maximum Height 14')
- Open Barn (5) or Outside Storage \$10/ft

TABLE RENTAL \$10/table (40 tables 8ft long & rectangular)

CHAIR RENTAL 2.50/chair (64 chairs)

SECURITY DEPOSITS

- \$500-1000 rentals = \$250
- \$1001 & Over rentals = \$750

One-half of building and/or ground rent plus the security deposit must be paid when the building/and grounds are scheduled. The remaining rent must be paid at least 14 business days prior to the scheduled event.

A Certificate of Liability Insurance for \$1,000,000 naming Green County Agricultural Society and Mechanics Institute as the certificate holder is required and is due 14 business days prior to the scheduled event.

*Activities restricting additional use of grounds except camping would be activities such as company picnics, trade shows, and such activities that would draw very large numbers of people which ties up most of the grounds with parking. Please check with fair office to determine if your activity is restricting additional use of the grounds and how rent will be determined.

*Additional charge is for each additional day the building is used for set up, clean up, or any other use providing another activity is not scheduled during that time. May not exceed more than 4 days in addition to the 3 days generally contracted.

Please be advised that there will be a 4% convenience fee added on to ALL credit card purchases
